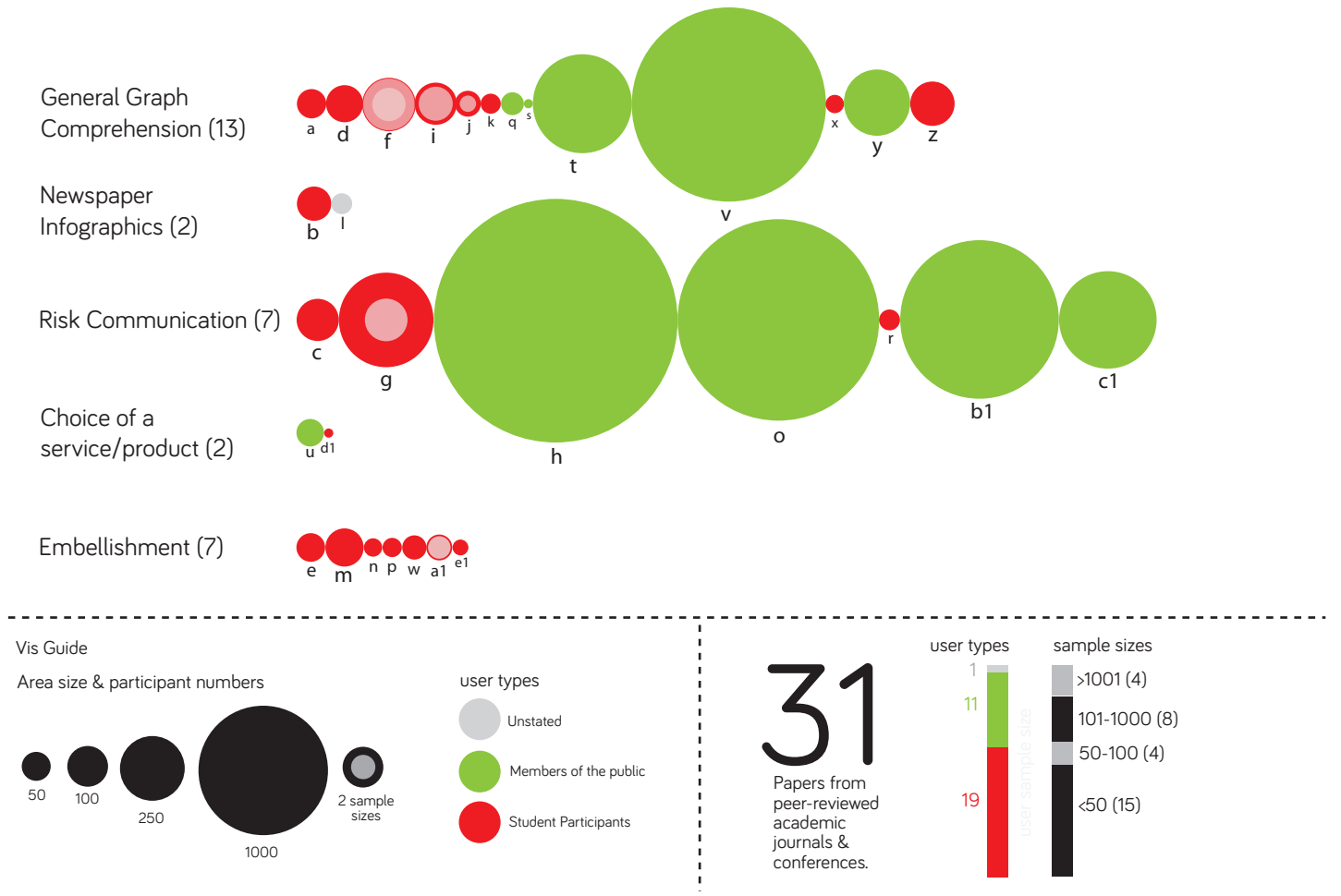


Evaluating infographics with users
